

PRIVACY POLICY & TERMS OF USE

In this Privacy Policy: www.rebeccasturmer.com

“Us, we, our” refers to Rebecca Sturmer, who operates this website.

“You, your” refers to any person who accesses any one of our platforms, whether you are a registered user of the application.

“platform/s” refers to this website, and any related website or application.

“POPI” refers to the Protection of Personal Information Act 4 of 2013.

When you access our website or make use of any services provided, we may collect certain personal information about you.

The personal information we collect about you may include but is not limited to:

- Your name
- Your address
- Your telephone numbers
- Your date of birth
- Your email address
- Your age

We will NOT collect:

- Your credit or debit card information
- Other information relating to your banking details
- Your billing address

We will NOT use or share your information with anyone except in accordance with POPI and as set out in this privacy policy and/or our terms and conditions of use.

We process the personal information we collect and receive to:

- Identify you
- Create a user account for you
- Provide you with services
- Provide you with important information about our services
- Notify you of important changes to our services

By using any of our platforms, you consent to the collection of your personal information and warrant that it is correct and consent to the use thereof as set out herein.

CHILDREN

We do not knowingly collect personal information about persons under the age of 18. (“children”). If you are under the age of 18 years, you must have permission from your parent or guardian before you use any of our services or give us your personal information. If we are unable to confirm that you have your parent or guardians’ consent, you may not use our services. To confirm your parent or guardian’s consent we may ask you to provide us with their contact details.

DISCLOSING YOUR PERSONAL INFORMATION

We will disclose your personal information if required to do so by law or subpoena.

YOUR RIGHTS
